

## **SUMMARY ANNUAL REPORT**

### **For KIMBALL ELECTRONICS MASTER WELFARE BENEFITS PLAN**

This is a summary of the annual report of the KIMBALL ELECTRONICS MASTER WELFARE BENEFITS PLAN, EIN 35-2079204, Plan No. 501, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

KIMBALL ELECTRONICS, INC. has committed itself to pay certain self-insured Medical, Prescription Drug, Dental, Short-term Disability, Employee Assistance Program, and Severance claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with EYEMED VISION CARE ON BEHALF OF FIDELITY SECURITY LIFE INSURANCE CO, LINCOLN NATIONAL LIFE INSURANCE COMPANY, RELIASTAR LIFE INSURANCE COMPANY, KAISER FOUNDATION HEALTH PLAN INC., and ZURICH AMERICAN INSURANCE COMPANY to pay Medical, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Business Travel Accident, Critical Illness, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$1,338,877.
